









## October 15-17, 2025 Missoula, Montana

In October of 2025, the United States District Court for the District of Montana will hold the ninth Montana Judicial Institute in Missoula. The goal of the Institute is to heighten public understanding of the Judiciary. The Institute provides an in-depth education program for high school teachers from throughout the district. The fundamental premise of the three-day seminar is to expand teachers' knowledge of the judiciary and its role in our system of government and societal organization as a whole.

The Institute's faculty will consist of judges, professors, the clerk of the U.S. District Court, and leading Montana attorneys. The curriculum of instruction will include:

- The Rule of Law
- Anatomy of a Criminal Case
- The Jury System
- Anatomy of a Civil Case
- Tribal Jurisdiction
- Federal & State Appellate Courts
- The Bankruptcy System

This continuing education course for high school educators is open to a limited number of participants whose travel, lodging, and meal expenses will be covered. With a faculty of around twenty, the student-faculty ratio is approximately 1:1.3, extremely conducive to a rewarding educational experience. Participants will receive licensure renewal units and will be eligible for one graduate credit through the University of Montana.

### Logistics & Planning

COMMITTEE PLANNING: Committee members include U.S. District Court judges, 9th Circuit lawyer representatives for the district, and the clerk of court.

#### VENUE PLANNING:

- Lodging arrangements have been made at a hotel near the courthouse in downtown Missoula.
- A number of the Institute's sessions will be held at the Russell Smith Federal Courthouse.

COSTS/PARTICIPANT REIMBURSEMENT: All expenses will be paid for the teacher participants from federal court attorney admission funds.
