1. Complete and sign the petition and oath card
 - a. The petition must also be signed by an attorney in good standing with the District of Montana.
 - b. The information provided on the oath card will be the information used to create your attorney profile in the CM/ECF database.
 - c. Once completed, mail the ORIGINAL petition and oath card to:

2. Submit Admission Fee of \$255.00 (as of December 1, 2016)
 - a. Pay over the phone or in person with a credit card
