### **SIGNATURE REMINDER - Affidavits & Declarations**

Under L.R. 11.1(d) and 11.2, a registered user may use the electronic "/s/" signature form only when signing a document as the filer or when signing a document requiring multiple signatures. All affidavits and declarations must be signed by hand.

### **ATTENTION: CJA Panel Attorneys**

In order to ease the process of preparing transcripts, the Court requests that when filing a Transcript Designation form electronically, that you also attach a completed CJA 24 form bearing your electronic signature in box number 15. Upon receipt of the CJA 24 form, the court reporter will take the necessary steps to obtain the signature of the presiding judge, and process the transcript accordingly.

### **Revised Local Rules of Procedure**

Proposed changes to the Local Rules will take effect shortly. Opportunity to submit comments to <u>LocalRules@mtd.uscourts.gov</u> closes Friday, January 24, at 5:00 p.m. After the Court adopts any proposed changes, the New Rules and their effective date will be posted on the district's website.

Among the proposals: preliminary pretrial statements must identify witnesses with discoverable information and describe applicable insurance agreements; parties must prepare and plaintiff file a Statement of Stipulated Facts along with pretrial statements and discovery plan; a party opposing summary judgment must respond verbatim to the moving party's statement of undisputed facts; patent, trademark, and copyright litigators must file applicable new forms; and when you settle a case, you must file a notice to let the court know. There are others! Check the website for a complete set of the proposed amendments.
