CLERK OF COURT

CM/ECF: Redaction of Personal Identifiers

We continue to experience documents being filed which contain personal identifiers. All filers in the District of Montana are reminded of the rules requiring the redaction of personal identifiers. The clerk is not required to review documents filed with the court for compliance with the rules regarding redaction. The responsibility to redact filings rests with counsel and the party or nonparty making the filing.

Pursuant to Fed. R. Civ. P. 5.2 and Fed. R. Crim. P. 49.1, all filers must redact the following: Social Security or taxpayer-identification numbers, dates of birth, names of minor children, financial account numbers, and, in criminal cases, home addresses. This pertains to <u>any</u> filing (including attachments), whether it be electronically filed or conventionally filed.

Before registered users can log into CM/ECF, they are required to check a box on the login screen acknowledging that they understand the redaction rules (see below). Access to file in CM/ECF will not be granted until the acknowledgment box is checked.

Authentication Login: Password:	IMPORTANT NOTICE OF REDACTION RESPONSIBILITY: All filers must redact: Social Security or taxpayer-identification numbers; dates of birth; names of minor children; financial account numbers; and, in criminal cases, home addresses, in compliance with Fed. R. Civ. P. 52 or Fed. R. Crim. P. 49.1. This requirement applies to all documents, including attachments.
