ADMINISTRATIVE ORDER 24-02


The Court hereby finds that Caoimhe Mulligan (PACER ID 7814370), Sadhbh O'Leary (PACER ID 7816127), Lauren D'Angelo (PACER ID 7813698), Brian Brammer (PACER ID 7799026), and Monte Cole (PACER ID 7275305) fall within the class of users listed in the fee schedule as being eligible for exemption from the fees imposed by the Electronic Public Access fee schedule adopted by the Judicial Conference of the United States Courts. An exemption is necessary in order to avoid unreasonable burdens to Ms. Mulligan, Ms. O'Leary, Ms. D'Angelo, Mr. Brammer, and Mr. Cole in their research. Accordingly, Caoimhe Mulligan, Sadhbh O'Leary, Lauren D'Angelo, Brian Brammer, and Monte Cole shall be exempt from the payment of fees for access via PACER to the electronic case files maintained in this court, to the extent such use is incurred in the performance of their research. Ms. Mulligan, Ms. O'Leary, Ms. D'Angelo, Mr. Brammer, and Mr. Cole shall not be exempt from the payment of fees incurred in connection with other uses of the PACER system in this court.

Additionally, the following limitations apply:

1. this fee exemption applies only to Caoimhe Mulligan, Sadhbh O’Leary, Lauren D’Angelo, Brian Brammer, and Monte Cole and is valid only for the purposes stated above;
2. this fee exemption applies only to the electronic case files of this court that are available through the PACER system;
3. by accepting this exemption, Caoimhe Mulligan, Sadhbh O’Leary, Lauren D’Angelo, Brian Brammer, and Monte Cole agree not to sell for profit any data obtained as a result of receiving this exemption;
4. Caoimhe Mulligan, Sadhbh O’Leary, Lauren D’Angelo, Brian Brammer, and Monte Cole are prohibited from transferring any data obtained as a result of receiving this exemption, including redistributing via internet-based databases; and
5. this exemption is valid January 16, 2024 through, May 17, 2024.

This exemption may be revoked at the discretion of the court at any time. A copy of this Order shall be sent to the PACER Service Center.
