The “No Change in Practice” column is marked if the proposed change in the rule is intended to reflect current practice or is limited to renumbering or relocation or stylistic change such as clarification, elimination of redundancy, or a change to standardize language – for example, substitution of “file” or “motion” for “submit” or “application.” Changes in the title of a Rule are reflected by underlining for new language and strike-through for deleted language.
